Call to Order/Announcements – Co-president Jenny Redfern called the meeting to order at 7:05 PM. Judy Kinker confirmed a quorum.

Guests and Proposal: The Grange – Nola Martini

Nola is the new Grange Master of the Morgan Hill Grange. Granges were established in the United States just after the Civil War, as a place where communities can come together, supporting farming and livestock. The Morgan Hill Grange philosophy is to be caretaker of the building, which was built in 1907. The Grange supports FFA at the high schools, provides scholarships, and opens the building for community meetings such as Boy Scouts, music, and dance.

The Grange would like form a mutually beneficial partnership with AAUW. AAUW would like to use the Grange building for events. The Grange is larger (capacity 120) than Villa Mira Monte, and a cheaper venue than the Community Center. The Grange would like AAUW to help them obtain historical status for their building and positive PR. Some or our AAUW members are also members of the Morgan Hill Historical Society, and are already working with the Grange to help them get historical status. The Grange would like more members, so they are requesting that AAUW members join. Membership is \$34 a year. The Grange is conducting a parking lot rummage sale with donated goods Sept 11 & 12. Karen Anderson is working with Heidi Golden, the Grange facilities manager, to schedule the October program and December holiday party there.

Minutes – The minutes of August 2015 board retreat were accepted with some corrections from Carol O'Hare.

Financial Report, 2015-2016 budget

CFO Peggy Martin reported her research and conclusion regarding the AAUW California Directors and Officers (D&O) insurance. The liability insurance through the state is for 2 million dollars per period, with a 5 million dollar umbrella policy for all of AAUW California. Peggy thinks we have adequate coverage. We paid \$737 last year for the insurance.

Peggy reported the proposed balanced budget with income and expenses equal at \$6445.00. Susan Oldham-Fritts moved that we accept the proposed budget, Joan Sullivan seconded the motion. The motion passed. The budget will appear in the October newsletter.

Membership Report: Brunch, renewals

Maggie Leininger & Joan Sullivan reported 137 paid members. Maggie named people who have not renewed, and asked board members to contact them personally by September 15th. The membership brunch was big, around 90 attendees. Maggie and Joan reported they considered the proposal from the board retreat to request more members for their team. They are concerned if they have more committee members, it would be more work for them. If they need more help, they will ask for help at that time. Jenny requested that they work with a member to lead the Neighborhood groups.

Committee Reports

Allocations Proposal and Positions - Jenny Redfern reported the allocations committee's proposal for allocating \$51,400 to local, state, and national scholarships and projects. Within the Scholarship allocations, Donna Dicker proposed a \$2000 scholarship for a Gavilan college nursing student, to be called the Lauren Jenkins Healthcare Profession scholarship. Kathy Sullivan (Downtown Association & RN) has agreed to lead this scholarship. The Tech Trek committee hopes to increase the number of Morgan Hill campers from 8 to 10. Susan moved that we accept the allocations and Donna seconded the motion. The motion passed.

Newsletter: change print delivery – Carol O'Hare reported that it is increasingly expensive to print and mail newsletters, \$1.80 for the September issue plus postage. 10 people get printed newsletters. Carol proposed that we take the newsletter to a copy shop, copy it double-sided, staple it and mail it, to decrease costs.

Taste of Morgan Hill: prep – Mary Cox reported we are almost set, but still need 6 more volunteers. Mary will host a booth mock-up at her house (with wine), the Wednesday before the Taste of Morgan Hill.

Gretchen Merrick, Publicity Chair, has created a flier (with help from Yvonne Duckett) to encourage women to join AAUW and visit our Taste Of Morgan Hill booth. The flier was distributed for people to place around town. Jenny ordered a new banner, "Be a Doer, Join AAUW Morgan Hill", to post at the

booth.

Bylaws: Judy Kinker reported on the proposed updates to Bylaws and Policies & Procedures to document how we select scholarship winners and disburse funds. The Scholarship and the Bylaws committees proposed changing Article 16 of our policies and procedures and addendum 6, a supplement to the Article 16 policy. Carol O'Hare moved that we approve article 16 and addendum 6. Many people seconded the motion. The motion passed. See attached for updated versions.

New Business

Scholarship Committee & Chair - Jenny Redfern proposed a scholarship chairperson to oversee the scholarship team. This may become a director position in the future. Janet McElroy is willing to be scholarship chair. The board approved this. The Bylaws Committee will make an addendum to the addendum. Margaret moved that we create a scholarship chairperson, Donna seconded the motion. The motion was approved. Addendum 6 will also need to be updated with criteria for the nursing scholarship.

Micro Loan/KIVA - Margaret McCann

Margaret reported that KIVA is an organization that gives repayable micro loans for developing countries, to educate more girls and women, create financial independence, improve health, and alleviate hunger.
