WFR Update (Deb Buchanan):

Everything is going well

332 runners registered/ ahead of the past three years

At this time no plans to cancel the event due to virus concerns

SVE timing company made suggestions for ways to handle virus concerns

Peggy will call State tomorrow to check about liability concerns with the virus.

Some suggestions were to clean tables, place hand sanitizer near food, perhaps postpone not cancel if possible

Deb will follow Committee's suggestions

WFR Sponsor (Barbara Palmer):

Barbara received a call from Sherry Dublin, Director of Employment Engagement at CDK Industries. She was impressed, heard about event from a San Jose employee, likes to reward groups such as ours, heard it was our 37th annual event, and offered \$1000 sponsorship So far \$29,500 in sponsorship donations, some new names, more paying booths this year

Wildflower Fund(Carol O'Hare):

37 members have made a donation to the fund, 11 sponsors. This is 21.3% of our membership, and last year 62% donated. Carol encourages all to donate

Young Women Leaders Update (Peggy Martin):

Waiting for the \$1,500 grant from Santa Clara County, it is coming but getting it was challenging \$10,000 from Clean Energy/ Help with climate change aspect Group has their own website, youngwomenleaders.org

Speech Trek Update (Joanne Rooney):

Joanne is looking for feedback on how to improve the recruiting process.

Initially sent emails to teachers (also translated into Spanish) for distribution to students.

Only 3 entrants/ 2 from YWL and 1 from Sobrato/ 2 Oakwood students dropped out the day of the event.
