## 2021 Wildflower Run Update (Pat Toombs, Carol O'Hare, Elizabeth Mandel):

WFR Membership Giving Campaign report (Carol O'Hare):

- Total \$18,009 donated so far, way above goal. Less than 46% of membership has donated. 8 members gave 65% of the total.
- Elizabeth is putting the list of member donors on our website.
- Letters are going out in May to members that have not donated.

Update on WFR Team and Meeting (Elizabeth Mandel):

- Final Registration is 335.
- Runner registration is around \$11,322.
- Final wrap-up 2021 WFR meeting is April 8<sup>th</sup>.
- Four banners that were up have been taken down.
- Final 8 packets are at BookSmart, will be taken back next week.

Update on WFR Prizes (Suman Ganapathy)

- Prizes is final item. Getting people to register on Facebook and submit things to Janet Wright by April 5<sup>th</sup>.
- Morgan Hill Life will publish a final article on the run.
- Venue for selection of Grand Prize will be the AAUW bench on at Morgan Hill House.

## **Bylaws (Carol O'Hare):**

- Addendum 6, Scholarships and Grants, changes made in several grants.
  - o Carol requested board approval of addendum 6, part one, passed unanimously. Specifics found on Dropbox.
- Webmaster job description has been completed.
  - o Carol requested board approval, passed unanimously. Specifics found on Dropbox.
- National will hold a Zoom meeting to discuss the vote to change membership degree requirement.
   This would be a change in bylaws, required a 2/3 vote of quorum of National. National voting on this starts April 7<sup>th</sup>.
  - o A very good webinar on the topic is available on the National website.
  - o Proposing a branch-wide Q&A meeting on Tuesday April 6<sup>th</sup> regarding this vote to discuss this further.
  - o Both sides will be presented.
  - o Board agrees as a unanimous entity that we support this proposal for "open membership". We will lead with this on our branch-wide meeting on April 6<sup>th</sup>. Marian made a motion that we put together a MH board recommendation of the National position that we change our bylaws to reflect open membership. Carol Seconds. Passed Unanimously.
  - o Discussion on a phone tree for contacting members about vote.

# **Allocations Update (Elizabeth Mandel):**

  - o 18% dropped out last fall, single parents, other students.
  - o Need money for food, transportation, rent. Money allocated based on need.
  - o Existing fund has \$25,000 in if, so additional 5K would really help.
- Tell Gilroy AAUW that we're doing this donation.

Motion made by Elizabeth to give \$5,000.00 to the Gavilan Emergency Fund. No second needed, motion passed unanimously.
