# Bylaws (Carol O'Hare) 2 Documents:

1. The purpose of the Board of Directors for nonprofit organizations (from BoardBuild.org)

- Advance and advocate for the mission of the organization, and set its strategy and goals.
- Govern and oversee the organization's operations, and ensure compliance with legal and ethical standards.
- Provide financial oversight and management, and oversee issues such as donations, contracts, fees, grants, insurance, etc...
- Craft policies and procedures to support the organization's goals and operations

#### **Board of Directors composition** (from Robert's Rules of Order, Newly Revised)

Boards have the authority to meet to determine courses of action in the name of the organization. A board is the administrative arm of an organization. It can do only what the bylaws allow.

[AAUW MH Bylaws Article XI Board of Directors, Section 2. Administrative Responsibilities: "The Board shall have the general power to administer the affairs of the Branch, including but not limited to establishing policies and procedures to control financial records. It shall accept responsibility delegated by AAUW and AAUW CA."]

As a board member, what you need to know to participate properly in board meetings depends on their size. If more than about a dozen members at a meeting, [formal] procedures are followed. If, however, not more than about a dozen board members are present, a more informal procedure is followed.

(from Roberta's Rules of Order: A guide for non profits)

Consider slimming down your board. If your organization has a large board, consider reducing it to a smaller, governing board. The best way to slim down the board is to separate governing responsibilities from other functions. Your leadership selection team should look for good managers for the governing board, fundraisers for a financial advisory council, and community representatives for a community council of advisors.

Each organization needs to identify its essential functions. Once identified, then organizations know how many board members are needed and are better able to recruit the right people to do the work. Avoid having members at large or members that represent one constituency or point of view. All members should be able to carry out a specific board task.

Ideally, each director will recruit more talent from the membership. In this way, the board members will become team leaders and not independent contributors. Their role becomes one of cultivating and mentoring potential leaders who can in turn move easily into the board roles.

#### 2. Summary of Term Limits Input from Branch Members

No Term Limits:

- No term limits.
- Keep things as they are.
- If someone is willing to give their time, then why limit them?
- Chair position openings are hard to fill (therefore no term limits?)
- If you cannot find a replacement, the member should be given the option to continue.
- Willing and dedicated volunteers should not be regulated with term limits.

#### **Term Limits:**

- Term limits for elected officials only.
- There should be term limits to prevent burn out.
- Terms limits for all elected and appointed positions.
- Term limits of two consecutive one-year terms for elected positions.
- Term limits of three consecutive one-year terms for appointed positions.
- Term limits are a good thing, but in cases where a specific skill set is called for (Ex. Treasurer) and there is no one to take the job, then an exception must be found for the current officer to continue for another year.
- I am in favor of board term limits. I highly recommend Term Limits of 3 years, with 1 consecutive option for 3 more years. This works well and is the most common non-profit limit from professional board advisors. First year is getting up to speed; second and third year up to speed.
- Elected positions with a 1-year terms are too short to be effective.
- Elected CFO position has a term exception outside of other elected positions.
- Appointed voting positions without limits (and officers with limits) potentially give the board an upside-down authority concentration.
- Appointed voting positions without limits have greater potential to dictate instead of give advice. They may intimidate newer board members.
- Appointed non-voting positions seem to be more like staff positions. Do term limits apply for these positions?
- Committee chairs should have term Limits of 3 years, with 1 consecutive option for 3 more years. After 3 to 6 years, you could rotate chair to a committee position on same committee.
- A rotation system could be followed of 1 year in various positions that lead to President.
- I believe that any elected position should be for two years with the person who will take over in place and learning the ropes. I think it's fine for people to come back after a year off.
- "A year to learn and a year to burn" burnout. People become stale.

#### **Training and Mentoring:**

- Some positions require training and mentoring.
- There needs to be a planned mentorship element to other board jobs similar to the one in place for the President..
- It's easier to recruit people if you can say it's only for two years, rather than to keep it open-ended.
- I don't think mentoring is done enough. Or at least getting to know new members well enough to encourage them to volunteer. Some don't have confidence in themselves to put themselves forward to do something that's visible to the possibility of criticism by people who are longtime members and basically strangers.
